Copyright

- Buying something should entitle you to all (and the highest possible quality) versions of the item, and if the various formats are not provided explicitly by the copyright holder, the consumer should have to right to be able to obtain it on their own from any source.
- The accessibility of music, whether free, paid, or compensation-per-stream, should be determined by the producer of the music and cannot be captured in one general law by the federal government.

- Data mining should be utilized by companies because it provides economic benefits to both the consumer and corporation.
- The landscape of privacy is changing dramatically with the introduction of wearable technology, just as with the previous waves of the PC and the smartphone, the reduced privacy should become the norm with its advances.

Governmental Access to Private Information
